
BUSINESS FOLLOWS THE PAY ENVELOPE

THE FIVE FULLDING PARAGRAPHS AND A REPRINT FROM THE WISCONSIN TAXPAYERS ALLIANCE NEWS RELEASE.

"EMPLOYEES OF THE STATE OF WISCONSIN ARE
MORE FORTUNATELY SITUATED THAN ARE THE EMPLOYEES OF
LOCAL UNITS OF GOVERNMENT OR THOSE EMPLOYED IN BUSINESS AND INDUSTRY, AS THEY HAVE NOT RECEIVED A PERMANENT SALARY OR WAGE CUT.

THIS IS BROUGHT OUT IN A STATEMENT ISSUED BY THE WISCONSIN TAXPAYERS ALLIANCE WHICH STATES THAT "COMPLETE DATA ON THE SALARY REMISSIONS OF VAR-IOUS STATE BOARDS AND COMMISSIONS IS NOT AVAILABLE." THE STATEMENT DOES SHOW, HOWEVER, THAT EMPLOYEES OF SOME OF THE STATE DEPARTMENTS HAVE MADE REMISSIONS OR WAIVERS WHICH APPLY ONLY TO SALARIES FOR THE FISCAL YEAR ENDED JUNE 30, 1933.

THE RELEASE BY THE WISCONSIN TAXPAYERS AL-LIANCE SAYS: LEITERS RECEIVED FROM A MAJORITY OF THE COUNTIES AND CITIES OF THE STATE INDICATE THAT SALARY AND WAGE CUTS, MOST OF THEM PERMANENT OR JUNTIL THE EMERGENCY PASSES!, RANGE FROM 5% TO 25 %.

CUT AS MUCH AS 25%. IN ADDITION, MANY EMPLOYEES ARE WORKING PART T:ME ON THIS REDUCED WAGE SCALE.

IN COMPARING THE INCOME OF THE STATE EMPLOYEE WITH THAT OF THE BUSINESS AND INDUSTRIAL EMPLOYEE, ONE MUST APPRECLATE THAT THE FORMER HAS A POSITION THAT OFFERS CONTINUOUS EMPLOYMENT WHILE THE EMPLOYEES OF BUSINESS AND INDUSTRY ARE LARGELY WORKING ON PART TIME IF, INDEED, THEY ARE WORKING AT ALL.

THE NEED FOR A COOPERATIVE MOVEMENT TO CURB SCHEMES FOR UNNECESSARY WAGE CUTS, FOSTERED BY UNREASONING, WAGE CUTTING INDIVIDUALS IS IMMEDIATE.

THE TWO FOLLOWING PARAGRAPHS ARE REPRINT-ED FROM THE SECTION CONCERNING PUBLIC EMPLOYEES AND TAKEN FROM THE REPORT OF THE GENERAL EXECUTIVE BOARD OF THE WISCONSIN STATE FEDERATION OF LABOR. THIS MATERIAL TOGETHER WITH A MASS OF OTHER VALU-ABLE DATA IS PRINTED IN THE PROCEEDINGS OF THE

FORTIETH ANNUAL CONVENTION OF THE WISCONSIN STATE FEDERATION OF LABOR. THIS CONVENTION WAS HELD IN WISCONSIN RAPIDS DURING JULY OF THIS YEAR.

"HERETOFORE THOSE IN CONTROL OF THE FINANCES OF THE COUNTRY HAVE DEVOTED MOST OF THEIR ENERGIES TO EFFECTING "ECONOMIES IN INDUSTRIES," I.E., THE LOWEST POSSIBLE WAGE AND THE MOST POSSIBLE HOURS, ON THE THEORY THAT MORE WOULD BE YIELDED IN PROFITS AND INTEREST. THEY HAVE ALSO "HELPED" THE FARMER TO EFFECT ECONOMIES TO THE POINT THAT HE NOW LIVES MOST ECONOMICALLY, ALMOST WITHOUT AN INCOME. THE STORY OF WAGE REDUCTIONS IN PRIVATE INDUSTRY IS TOO WELL KNOWN TO REQUIRE ELABORATION HERE. AFTER HAVING CONVINCED THE MASS OF UNORGANIZED WORKERS AND THE FARMERS THAT "HALF A LOAF IS BETTER THAN NONE," THEY BEGAN TO DIRECT THEIR ATTENTION TO DEFLATING THE ALREADY UNDERPAID MEN AND WOMEN WORKING FOR THE RUB-LIC IN TOWN, CITY, COUNTRY, STATE AND FEDERAL SERVICE. IT WAS NOT TO BE EXPECTED THAT A GIGANTIC NATION-WITE CONSPIRACY, ORGANIZED FOR THE PURPOSE OF "SHOW-ING THE MASSES ITS PLACE," WOULD FOR LONG OVERLOOK THE OPPORTUNITY TO DEFLATE THE APPROXIMATELY ELEVEN PER CENT OF THE WORK POPULATION WHICH IS ENGAGED IN PUBLIC SERVICE-THE SCHOOL TEACHER, THE JANITOR, LABORER AND CRAFTSMAN, ADMINISTRATIVE EMPLOYEE, THE CLERK, THE SWEEPER, THE FIRE FIGHTER AND POLICEMAN, THE FOREST RANGER AND GUARD, THE SCRUB WOMAN, THE STATISTICIAN, ETC .- ALL FOR THE PURPOSE OF AVOIDING A TAX ON THE ILL-GOTTEN WEALTH WHICH HAS PUT THE

ORGANIZED LABOR MUST AGAIN, AS IT HAS FRE-QUENTLY IN THE PAST, COME TO THE DEFENSE OF GOVERN-MENT AND THOSE IN THE PUBLIC SERVICE. WE CAN NOT , AFFORD TO PERMIT PUBLIC SERVICE TO DETERIORATE. IN TIME OF EMERGENCY IT IS EVEN MORE IMPORTANT THAT THE FUNCTIONS OF GOVERNMENT BE MAINTAINED AT THE HIGHEST POINT OF EFFICIENCY. EFFICIENCY CAN NOT BE MAINTAINED BY APPLYING THE FALSE ECONOMY OF PEN-URY TO THE SEVERAL DEPARTMENTS AND PAUPERIZING THE PERSONNEL ON THE SERVICE." OT . OHIU ATRON. ********* IT . JENTER OF TO . TIMS OF PROPOSALS FOR EXCESSIVE WAGE CUTTING, WHICH CAN ONLY BE MET EFFECTIVELY, THRU ORGANIZED EFFORT.

WHAT ARE YOU DOING TOWARD PARTICIPATING IN THE ASSOCIATION ORGANIZED BY YOUR FELLOW EMPLOYEES?

WHY I AM A MEMBER OF THE WISCONSIN STATE ADMINISTRATIVE EMPLOYEES ASSOCIATION, IS ANSWERED BY F. A. STATEN OF THE DEPARTMENT OF AGRICULTURE AND MARKETS. Mr. STATEN GIVES THE FIVE FOLLOWING REASONS.

- I. BECAUSE FACTS REGARDING THE STANDARDS, TRAINING AND SALARIES OF GOVERNMENT PERSONNEL AS COMPARED WITH THE PERSONNEL OF BUSINESS AND INDUSTRY SHOULD BE PRESENTED TO THE PUBLIC AND TO THE LEGISLATURE.
- 2. BECAUSE I BELIEVE IT UNLIKELY THAT ANY INDIVID-UAL OR GROUPS OTHER THAN THE STATE EMPLOYEES THEMSELVES MAY BE RELIED UPON TO PROPERLY PRE-PARE AND PRESENT THESE FACTS.
- 3. BECAUSE THE INDIVIDUAL STATE EMPLOYEE IS ABSO-LUTELY UNABLE TO ADEQUATELY KNOW OR PRESENT THESE FACTS, COOPERATIVE ORGANIZATION IS NECES-SARY TO PREPARE AND PRESENT THE FACTS.
- 4. BEGAUSE THE UNORGANIZED AND UNAFFILIATED INDIVIDUAL IS SELDOM CONSIDERED BY THOSE IN CONTROL.
 A UNIFIED AND AUDIBLE GROUP DOES GET CONSIDERATION, BUT SINCE ORGANIZED SMALL GROUPS MAY
 WIELD AN UNDUE INFLUENCE IN BREAKING DOWN THE
 STANDARDS OF STATE SERVICE, WE MUST BE ORGANIZED
 TO DOUNTERACT. THIS INFLUENCE.
- 5. BECAUSE THE STATE EMPLOYEES ASSOCIATION IS AFFILIATED WITH THE A. F. OF L. WHICH IS ORGANIZED TO INSURE EFFECTIVE REPRESENTATION AND RESONABLE TREATMENT OF ITS MEMBERS. AFFILIATION
 WITH THE A. F. OF L. IDENTIFIES THE ASSOCIATION
 WITH A GOING LEGISLATIVE AND EDUCATIONAL CONCERN.
