President's Corner by Maura Powers

Greetings since last year's newsletter! Since then, we have been in between legislative sessions, so not much affecting our pension plan has been going on.

Last summer, I reported to you that the ERS Board of Trustees was considering reducing the assumed rate of return on investments a full percentage point from 8% to 7%.

This would have made it appear that ERS needed several billion



more dollars in order to pay retirees' pensions in the future. We knew from past experience that the legislature was unlikely to appropriate several billion dollars for the plan. And, our plan would be susceptible to even more bashing by those people who oppose it.

So, we asked our members to email the trustees that a reduction to 7% was not justified. Thanks to our membership's communication efforts, the trustees, in a highly unusual 4-2 vote, reduced the rate by only half a point to 7.5%, the highest rate the consulting actuaries would approve. While half a percentage point may not seem like much, there is now estimated to be \$2.1 billion more in the plan than had the rate gone all the way down to 7%.

This whole episode shows the importance of electing trustees who will take into consideration the views of state employees and retirees. The next trustee election will be in the spring 2019. Please be on the lookout for it.

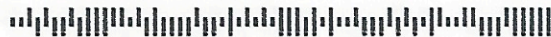

In a new program by the Texas Department of Health and Human Services Commission called "OwnYourFuture," the state is trying to prepare new retirees for their future by informing them of the costs of aging.

In Texas, a home health care aide averages \$3,817 per month.

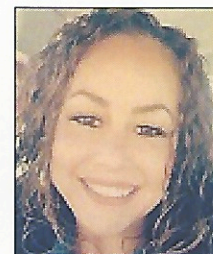
According to a study completed by Seniorhomes.com, an assisted living facility costs a minimum of \$3,500 per month. And, if you are a retired woman, you can expect
