### 3. Approval of Treasurer's Reports

- Motion made by Pedersen to approve report for June 2025, seconded by Sealy. Motion passed with 9-0 vote.
- Motion made by Pedersen to approve report for August 2025, seconded by Sealy. Motion passed with 9-0 vote.
- Approval of September 2025 report tabled until next meeting because no payments received. Late reimbursement payments from Council 36 have become habitual problem.
- The new postal address for Local 18 is PO Box 2142, City of Industry (or La Puente), 91746.
- Arrears audit: Local 18 was invoiced incorrectly to their benefit. More info is needed to determine who will be responsible for shortfall.
- Approval of Pedersen inquired about process for arranging automatic payroll contributions to PEOPLE (Public Employees Organized to Promote Legislative Equality), the lobbyist arm for AFSCME in Sacramento. Per Schmidt, arrangements would have to be made with HR but not much interest from membership expected.

#### 5. Discussions with HR

- Telematics – Board met with HR and Bolderoff on Sept 9 and opposed inward-facing cameras. Driving data are already being collected without a new system and are available to managers and supervisors, but it is not being used according to Travelers (insurance company).
- 401(a) Proposal
  - On Sept. 16, Board members met with financial consultant JoAnn Parrino who advised that there is basically no downside to the 401(a) plan.
  - Motion made by Sealy, seconded by Hope, to request that all employees receive matching contributions based on total compensation, as does Management, rather than base pay. Motion passed with 9-0 vote.
  - Suggestion was made to request additional percentage contribution for PEPR employees but this will have to wait for negotiation.
- CalPERS EPMC Reporting – Due to archaic system of COLA calculation, recently retired employees were getting a small bonus. Going forward, they will be receiving the correct amount.

#### 6. Report from AFSCME Representative

- Schmidt recommended that membership be allowed to vote whether to accept the 401(a) proposal.
- At Schmidt's request, motion made by Garcia, seconded by Pedersen, to authorize \$50 payment for list of arbitrators for the previously filed arbitration request for the TS employee. Motion passed with 9-0 vote.
