## MUNICIPAL ELECTIONS

Local city council elections are extremely important to our union, as mayors of Districts' cities serve on our agency's Boards of Directors and make decisions that directly affect our members' employment benefits. Your Local 18 Board of Directors carefully considers candidates seeking our support before offering an official endorsement. We fully realize that our membership has varying political beliefs and affiliations and that it would be impossible to find candidates who appealed to everyone's opinion on every single issue. Therefore, we ONLY consider whether a candidate has demonstrated his or her support of labor in the past, has pledged to work with us in the future, or if their opponent is known to be openly hostile to our union and its members. These are the only considerations as they are the ones that directly impact each one of you, our members.

That said, your Board of Directors are pleased to offer our endorsement to **Mr. Victor Gordo** for Mayor of the City of Pasadena and **Mr. Andre Quintero** for Mayor of the City of El Monte. Finally, our new Constitution requires the selection of three "**Trustees**" who will be separate from the Board and will only meet four times a year to audit our union's finances.
