Vote - Yays: 89% Nays: 11%

A motion to adjourn the Emergency General Membership Meeting from June 23rd, 2021 at 6:49 p.m was made Bro. Antonio Jordan, District 9 and it was seconded by Sis. Rosemary Moyano, District 25.
