The Power of AFSCME Sisters

March is Women's History Month, and as we come to the end of month, I can't help but reflect on the power of our AFSCME sisters and everything they've done to lift up women across the country.

Did you know that it was our AFSCME sisters who were the first group of women to successfully win pay equity for their work? On July 5, 1981, AFSCME Local 101 went on strike to demand pay equity for all of the women employed by the City of San Jose in California. Ten days later, the workers were victorious, and their final agreement included pay raises and additional money set aside to bring all of the women employed by the city up to par with their male counterparts. The organizing done by these AFSCME sisters started a movement across the nation for pay equity in the workplace.

There is truly no other force but a union that brings wage equity to our jobs. Our union contracts ensure everyone will be compensated fairly no matter what. And this month and every month, we'll keep organizing and fighting until all workers are treated fairly!

AFSCME Members Win \$23 Million Wage Theft Settlement!

On March 13, the Board of Public Works (BPW) approved the final portion of a nearly \$23 million wage settlement that affected nearly 6,000 correctional employees across Maryland, making this the second largest wage theft settlement for correctional officers in the history of the United States.
