Manifestations Of Racism

Malicious

Malicious racism is ugly, violent and socially destructive, burning crosses and white hoods, hurtful words and angry comments. Easy to identify and easy to identify and easy to condemn. Insisting that racism can only take this one form is political strategy

Coded

Coded racism works by invoking racial stereotypes. The coded part comes in that politicians deploy these stereotypes without expressly mentioning race. Thug v frat boy Welfare mom Anchor baby Routine/ Cultural For most of us racism is routine, commonsense, forming part of our everyday understanding of the world, even for people who mean well, and even for people of color.

Systemic/ Institutional

Institutions (education, HC, unions, school to prison pipeline) support the systems and contribute to and reinforce racist systems – if you can interrupt one, you can interrupt the entire system

Strategic

The decision to manipulate the racial fears and hatreds of others for selfish ends. The "strategy" in strategic racism is to divide and conquer, and it has been at the core of American politics for the last half-century.

The Creation of Race

There is only one race: the human race.

The idea that there are separate races is a human invention. Skin color or place of origin do not indicate real biological categories or show innate traits by birth. Instead, race is a set of social categories created by elites who profited and ruled by doing so.

European and American elites wanted slave labor to help them accumulate further wealth, so they kidnapped millions of people from Africa. To justify mass abduction and enslavement and the horrifying brutality that went with it, they claimed that Africans were a subspecies and biologically inferior to Europeans.

"Race" is a set of social categories created by elites for their own profit and ruling power.

Similarly, claiming that indigenous "American Indians," were a separate and inferior subspecies justified exterminating them while grabbing land and resources.

Slaveholders and the rest of the 1% of their day protected their economic interests by creating a racial hierarchy to divide slaves and White workers from one another.

"Race Science"

In the late 1800's, a pseudoscience developed around the idea that race is a biological category. They claimed that race biology determines how smart we are and what we are capable of doing. In the early 20th century, even the Federal government used "race science" to rank groups who could emigrate to the U.S. At the time, nationalities and religions like Southern Italian and Jewish were also assumed to be biological races (and quite "inferior" to White Europeans).

Corporate managers also used "race science" to carve up the workforce into who was qualified to do what. Of course, their goal was to prevent union organizing by dividing the workforce. The fact sheet on the next page shows the result of one such effort.
